# 1: Jointly Developed

### 2: Annual Title I Meeting

The Annual Title meeting will be held virtually and posted on the school's facebook page on August 10, 2021. The meetings will be led by Dr. Moore, Principal. This meeting will inform parents of the requirements of Title I, their rights under Title I, and how the school is meeting these requirements.

### 3: Communications

Central Elementary will make the school parent family engagement plan by placing a link on the school website, sending home copies of the plan, and having copies of the plan available at the school in the parent resource center. We believe that a partnership must exist between our parents and our school. We promote positive communication between the school and our students' homes.

- School staff will communicate in many different ways to provide additional information to parents and to increase parent involvement in supporting classroom instruction.
- The school will hold family nights, conferences, and activities regularly throughout the year to increase parent involvement and build staff and parent capacity to engage in these types of efforts. ### 9: Building Capacity - Discretionary

If any event causes future school closing and a move to remote learning, Central Elementary will support students and parents in a variety of ways. Central Elementary will use blended learning to teach our current curriculum, starting at the beginning of school. This will enable a much smoother flow to remote learning in the future. Students will start the school year using Google Classroom so that they are familiar with this procedure from the beginning. Students will be assigned a school-issued chromebook that they will bring back and forth to school daily. Teachers and staff will use social media, emails, virtual newsletters, phone calls, and other forms of communication to maintain a good relationship with families. Central Elementary parents can also use the Google Classroom app to monitor their student's progress. In addition, parents can use the GoGuardian Suite app to monitor their student's computer usage, both at home and at school.

In the event of remote learning and closure of school buildings to the public, Central Elementary will conduct its parent engagement meetings as an online event. In addition, if the Van Buren School District does have to move to remote learning and close buildings, some parent events such as conferences may be moved online or postponed. The school will use social media, emails, and phone calls to keep in contact and help support students and families in the event of more remote learning.
